**MESSAGE FROM THE PRESIDENT – DAVID SHERRY**

**Dune Planting** – Volunteers are needed to help plant sea oats and panic grass on the dunes on Okaloosa Island. Okaloosa County *estimates* the dune planting will begin around Saturday, April 3. There will be no planting on Easter Sunday, April 4.

Dune planting is a simple process: drill a hole in the sand (drill provided by the County), drop in fertilizer and a seedling, close the hole by hand, and water.



Okaloosa County's Tourist Development Department (TDD) is managing the project, with project costs being shared by FDEP and the Okaloosa County TDD. Our thanks go to FDEP, Okaloosa County, the TDD, and all the volunteers for making this project happen.

Please contact OILA President David Sherry if you would like to volunteer to help plant the dunes. If you have a location preference for where you want to plant, please include that information.

As with the beach clean-ups, volunteers will need to sign a liability waiver. Volunteers should wear comfortable clothing and shoes. More details will follow as the date draws closer.

**Beach Clean-Up** – Okaloosa County's next beach clean-up is Saturday morning, April 24. Volunteers will need to sign a liability waiver. More details will follow at a later date.

**Brooks Bridge Replacement** – The Florida Department of Transportation (FDOT) will host a virtual bridge aesthetic workshop for the Brooks Bridge Replacement project. ### WORLD WAR 2 TECHNOLOGY CREATED THE ATOMIC BOMB AND THE "SLINKY"

FOLLOWING IS THE STORY OF THE "SLINKY"



In 1943, Richard James, a naval mechanical engineer stationed at the William Cramp & Sons shipyards in Philadelphia, was developing springs that could support and stabilize sensitive instruments aboard ships in rough seas. James accidentally knocked one of the springs from a shelf, and watched as the spring "stepped" in a series of arcs to a stack of books, to a tabletop, and to the floor, where it re-coiled itself and stood upright James's wife Betty later recalled, "He came home and said, 'I think if I got the right property of steel and the right tension; I could make it walk.'" James experimented with different types of steel wire over the next year, and finally found a spring that would walk. Betty was dubious at first but changed her mind after the toy was fine-tuned and neighborhood children expressed an excited interest in it. She dubbed the toy Slinky (meaning "sleek and graceful"), after finding the word in a dictionary and deciding that the word aptly described the sound of a metal spring expanding and collapsing

With a USD \$500 loan, the couple formed James Industries (originally James Spring & Wire Company), had 400 Slinky units made by a local machine shop, hand-wrapped each in yellow paper, and priced them at \$1 a piece. Each was 2½" tall and included 98 coils of high-grade blue-black Swedish steel. The James family had difficulty selling Slinky to toy stores but, in November 1945, they were granted permission to set up an inclined plane in the toy section of Gimbels department store in Philadelphia to demonstrate the toy. Slinky was a hit, and the first 400 units were sold within ninety minutes. In 1946, Slinky was introduced at the American Toy Fair.





**CALL TO ORDER:** Meeting called to order at 7:00 PM by **President David Sherry** via Zoom due to Covid-19.

**I. PLEDGE OF ALLEGIANCE:** Pledge of Allegiance led by **President David Sherry**.

**II. ROLL:** Board Members Present: **David Sherry (President), Rick Deckert (Vice President), John Donovan (Secretary), Ed Henderson, Jesse Hunt, Jack Pous**.

**III. MINUTES:** Secretary John Donovan made a motion, seconded by Jack Pous, to approve the draft January 11, 2021 minutes (passed 29-0).

**IV. TREASURER'S REPORT:** Presented by President David Sherry on behalf of Treasurer Jim Simpson (See Attachment 1). A motion to approve the January 11, 2021 Treasurer's report and to pay reimbursements was made by Secretary John Donovan, seconded by Vice-President Rick Deckert (passed 27-0).

**V. COMMITTEE REPORTS:**

**Standing Committees**

**Architectural Report:** President David Sherry stated the ARC report is in the OIL Lantern, and that one application was approved in January.

**Ad Hoc Committee Report**

**IT Modernization Committee:** President David Sherry read the motion which established an ad hoc committee at the December 14 meeting. "Jackson Bain made a motion, seconded by Director Brick Bradford, to establish an ad hoc committee composed of Secretary John Donovan, Director Jesse Hunt, Don Didier, Dylan Hunt, and Lisa Johnson, to investigate future OILA online record storage options, limiting the scope to key documents and key emails generated going forward, including who will do the work, what is the cost, and what technology platform(s) can be used. The ad hoc committee will report to the OILA board and membership by the February 8 meeting."

Committee members Jesse Hunt and John Donovan both gave committee reports, with differing positions, followed by questions and comments from the membership and board of directors.

Director Jesse Hunt, a committee member, gave a progress report stating his position. He believes there will be a lack of records availability as directors transition out of their positions. Director Hunt proposed a cloud based system with 12 new accounts with e-mail addresses for \$432 per year. He would eliminate the OILA website and Zoom for meetings to offset part of this cost. He would change the way Treasurer Jim Simpson's records are provided by Jim and stored, and impose new business rules and file nomenclature rules on OILA and its board of directors. Director Hunt stated there was no support within the OILA board for the actions he proposed.

Secretary John Donovan, a committee member, gave a progress report stating his position. He stated that the ideas expressed by committee member Jesse Hunt were very good. He described the current record keeping system, established when he was elected 18 months ago, and stated that he believes this system safeguards OILA online records very well. The system uses a cloud based e-mail account dedicated solely to OILA records, and was specifically designed to easily pass record custodianship to the next OILA Secretary. He supports the continued use of the OILA website, using Zoom for meetings, and insists on protecting the current system of membership record keeping and newsletter publishing by Treasurer Jim Simpson.

John Donovan stated his frustration that the ad hoc committee was intended to help shoulder his workload as Secretary, but instead has been adding to it. He said certain committee members may have strayed from the committee's mission scope; particularly regarding new e-mail addresses for board and committee members, and even worse, made contact with long time Treasurer and Newsletter Editor Jim Simpson to possibly suggest changes to how Treasurer and Publisher records are provided. Secretary Donovan said worst of all, the committee does not have an IT Coordinator candidate. Committee member Hunt's proposal requires that position, but no committee member was able to devote the large amount of development time and ongoing implementation effort that position would require.

Secretary John Donovan stated the five member IT Modernization committee was splintered, and unable to reach a consensus. The other three committee members were absent from this members meeting.

## DRAFT MINUTES – OKALOOSA ISLAND LEASEHOLDERS ASSOCIATION – FEB 8, 2021

President David Sherry asked if any of the board members, who would be tasked with learning and using any new system, had been contacted. Director Hunt confirmed no board members were contacted.

Secretary Donovan stated the board needed to be contacted for their opinions. Director Hunt disagreed, and said he considered his personal work an internal report that would eventually be shared with OILA members, and that is why he had not shared with directors.

Director Hunt said there needed to be a way for OILA information to be collected and made transparent. President Sherry explained there was a lot of OILA information already being collected – the dedicated OILA e-mail accounts for OILA Records and for the ARC (“Architectural Review Committee”), the OILA website, and the Facebook page were all being presently managed within OILA.

President Sherry said, when we communicate a resolution as a body stating a position that the OILA membership took, he copies the board, then the Secretary archives them. The intent is, and was from the start, that when John Donovan leaves that position, he will give the account password to the next Secretary.

President Sherry said he did not see the value in spending \$432 annually for 12 new e-mail addresses that no one who currently does the work has agreed to use. Secretary Donovan also opposed Director Hunt's push for 12 new e-mail addresses. President Sherry offered to send the key documents currently kept in a dedicated OILA e-mail account to a new, additional dedicated OILA records e-mail account. President Sherry also stated that the committee could store and share OILA records with membership by using one account, and there was no need for 12 new accounts in order to accomplish the mission tasked to the committee.

President Sherry recognized long time Treasurer and Newsletter Editor Jim Simpson for all the work he does. Mr. Sherry was disappointed Director Hunt's IT proposal might push more work onto Jim Simpson. President Sherry stated adding anything to Jim's duties was beyond the scope of the committee.

Director Hunt objected to limiting the scope of the motion which established the ad hoc committee. President Sherry re-read the motion verbatim, and asked who would be the person identified to lead this task. Director Hunt deferred, and said absent committee members Lisa Johnson and Don Didier were willing to provide limited support.

President Sherry stated the committee work had been crowding out member projects with higher priority, and stated his priority is to work on Santa Rosa Boulevard, East Pass sand, and dune planting for Okaloosa Island.

Jackson Bain, the author of the original motion, described his experience with a shared drive system at a large not-for-profit. He said that in his motion he had in mind a simple process. Jackson estimated that if a new records system were established, the ongoing time commitment would be 3 hours per day.

Kathy Foster said no one is going to volunteer for a job without knowing what this entails. Secretary Donovan stated per the OILA Bylaws the Secretary is the records custodian, and that is his job.

Several members made comments asking about the current records system. Gary Hunt stated OILA is not subject to the Florida Sunshine Law. He also asked what happens to ARC records. Nancy Hunt considers the OIL Lantern to be the best records OILA has. She also questioned how ARC records are stored. President Sherry explained OILA ARC records are currently stored in the current cloud based OILA ARC dedicated e-mail account, and that many historical records are available on the OILA website.

Director Ed Henderson said Director Hunt had mentioned the OILA web, and asked if he was planning on doing away with that. Director Hunt stated there are better ways to do it. Secretary Donovan repeated his support for keeping the OILA website, and stated eliminating the OILA website is far beyond the committee's scope. Secretary Donovan said we have a reporting of the committee, two members in disagreement, and reiterated we need to take this to the board. Director Hunt restated the board is unreceptive to his ideas.

Director Jack Pous summarized his understanding of the discussion. One of his concerns, from a prior administration, was that information be protected from a computer crash. President Sherry and Secretary Donovan confirmed OILA records are currently stored in the cloud, and under the current records storage system that records would not be lost in a computer crash.

**VI. UNFINISHED AND NEW BUSINESS:**

**VII. ANNOUNCEMENTS:**

1. President Sherry stated the Okaloosa County volunteer dune planting will be held around Saturday, April 3. The county has ordered more than 300,000 plants in a combination of sea oats and panic grass. Okaloosa County will first install sand fence with in house labor, then volunteers will plant the dunes. Nancy Hunt and Dave Hancock proposed Okaloosa County hire the unemployed rather than using volunteers, and will make this request to the TDC. President Sherry stated Okaloosa County purchased more plants than originally planned on the premise of volunteer planting. He said he could not in good conscience go to the county and ask them to change course at this late date. He added the volunteer dune planting had been discussed in previous OILA meetings and featured in two recent President's Letters in the OIL Lantern. Rebecca Sherry said she was gathering a list of volunteers, welcomed more, and reminded those present that we have volunteer planted Okaloosa Island dunes three times in the past. President Sherry said more details will be shared when available.
2. President Sherry reported per mailman Justin Hill, a North side of the island mail thief suspect has been arrested.

**VIII. ADJOURNMENT:**

The meeting was adjourned at 8:21 PM (motion by Director Ed Henderson, seconded by Director Jack Pous and passed 17-0).


