#### **MESSAGE FROM THE PRESIDENT – Brian Harrington**

This month we're going to have Mr. Jason Autrey, the Director of Okaloosa County's Public Works Department as our guest speaker. Mr. Autrey has agreed to provide our members with a much-needed update regarding Okaloosa County's plan to overhaul Santa Rosa Boulevard. As you know, this plan has been the cause of serious concern for all Islanders as it affects our quality of life and the safety of our families, guests, and visitors.



The purpose of this meeting is to receive a briefing from Mr. Autrey and this forum is not going to be a "town hall" style session—it is intended only to be an information update. I do not intend for him to stand and answer questions from the room as he has limited time. At a date to be determined after this briefing, the OILA membership will discuss any new information and following this discussion, our members will decide on what actions should be taken.

#### The OILA Board of Directors has complied the following list of questions for Mr. Autrey:

- Q. Why can't we retain 4 lanes of traffic on Santa Rosa Boulevard (SRB) that will ensure optimum safety as to ingress and egress for routine residential traffic (to include school buses, delivery vans, utility repair, evacuation and military traffic) and for the emergency vehicles of fire, police, EMS ambulance and beach rescue vehicles? Currently SRB is approximately 78 ft. wide from the north edge of the current sidewalk to the south edge of the eastbound lane. The county's easement along SRB is 100ft wide. The current four vehicle lanes are 10ft wide each and the median is 17ft wide—that only accounts for 57ft, and in SRB's current configuration this still leaves room for a 12ft multi-modal path and 9 feet of additional space for a south sidewalk or drainage as required—or does the current plan somehow now include vehicle parking along SRB?
- Q. Regarding public safety along SRB--assuming the speed limit remains 35mph, how exactly is the proposed plan safer for motorists, pedestrians & cyclists vs. the current configuration, and are emergency response times somehow shortened under the proposed plan? Several individual groups and professionals (including OILA's President, Past-President other OILA members and Island property owners, an Emergency Physician/Paramedic Medical Director, and a Forensic Structure/Traffic Engineer) testified to the dangers and consequences of reducing the lanes of traffic on SRB. What do you say to these individuals and to the 90% of OILA voters who voted against any lane reduction?
- Q. What official written support have you received from Eqlin AFB's Command Group in regard to the SRB plan? What concerns has the Eglin AFB commander shared with the design team in regard to limiting the travel lanes to the Santa Rosa Range Complex? Does the county have a formal Memorandum of Understanding or other legal written permission from Eglin AFB's Command Group to reduce any lanes of traffic on Santa Rosa Boulevard?
- Q. How is this plan going to improve drainage along SRB & how much green space is required to achieve this goal? Assuming this drainage channels its way into the beach freeways & eventually the sound, are there any future plans for the beach freeways other than drainage?
- Q. Can you share the construction timeline for the new water mains along SRB? We understand that Halff Associates has the design contract for both the SRB improvement project as well as the water main replacement plan. The county commissioners have also hinted that underground power lines may accompany the SRB plan--can you elaborate on this?
- Q. How far along are we in the process? How much of the \$610k that was approved in April of 2023 has been spent? What is the timeline for construction--will we see shovels in the dirt before the Brooks Bridge's projected completion date--or after its completion & how long after? Can an OILA director attend any of the scheduled monthly coordination & progress meetings and can OILA be made aware of what individual property owners are agreeing to?

We're looking forward to hearing the answers to these questions--make sure to clear your calendar and be sure to attend this meeting.





### **Draft Meeting Minutes OILA May, 13th 2024**

Board members in attendance: Brian Harrington, Frank Adcock, Louis Belanger, David Jones, Stan King

Board members not present: Dylan Hunt, Jerry Boggess

Officers present: Jim Simpson (Treasurer), John Donovan (Secretary)

Meeting started 7pm. Pledge of allegiance recited by membership.

John Donovan requested modification to the April minutes regarding Frank Adcock's comments discussing the SRB lane reduction. Change requested (below) was adopted and minutes approved.

"Frank Adcock – Frank asked if there had been any further communication from or to OILA with the Military (Brigadier General Geraghty) concerning the planned reduction of traffic lanes from four lanes to two on the Western one-mile of Santa Rosa Blvd? Frank repeated a phrase used in Brig Gen Geraghty's written communication to OILA that he stated he has no public position on this matter 'at this time'. This implies he may have something further to say at a future date about Okaloosa County's plan to narrow the only beachfront Eastern access to the 15 mile long Military Fly-In and Training area. Frank also mentioned the new beachfront Restaurant being built on the Island at its extreme Western end that would bring more traffic to that area not only from Island residents and vacationers but from local permanent residents of the Fort Walton area in general because this location would be a unique attraction in the history of Okaloosa Island."

Treasurers Report provided by Jim Simpson. Motion to approve reimbursement of postage was approved. Treasury report approved (see attachment 1 for a copy of he approved report)

ARC Report out (Nick Hall) – 1 approval on April 18th for the Beal House hotel to add exterior slate screening.

Guest Speaker from Okaloosa County Coastal Resources: (Jessica Valek, Coastal Resources Coordinator)

- Funded under the TDD
- Jessica runs the sea turtle nesting program.
- 4 of 7 sea turtle species are found in the Gulf.
- May  $1^{st}$  Oct  $31^{st}$  is nesting season where turtles come onto beach to lay eggs.
- Typically lay 80 to 100 eggs at a time.
- Turtle will bury the eggs and return to the gulf and not return to the nest. The eggs are left in the ground for 25 to 45 days until they hatch. They crawl back to the water and use the moonlight to guide them.
- Turtles will return to the area where they hatched.
- Temperature determines the sex of the turtle.
- Turtles depend on Sargassum for food and protection by way of camouflage.
- All sea turtles are protected, and the nesting program monitors the beach each day for new nests. New nests are marked with stakes and flagging with a sign posted to not disturb.
- After the eggs hatch, Sea Turtle Patrol evaluates the nest to determine how many eggs hatched.
- Things we can do:
  - o Filling in holes on the beach, knocking down sandcastles.
  - o Pick up all items off the beach.
  - o Reduce the amount of light on the beach during the evening as turtles like the dark.
  - o Utilize red light instead of white flashlights as they impact the turtles.

#### Santa Rosa Blvd Update:

#### **Topic 1 Water main line replacement:**

During the May 7 BBC meeting, Mike Hacket from water and sewer requested \$127k to design the replacement of the water main on the south side of SRB. Currently an iron line that was likely from the 50s. Requested to upgrade this line from 6' to 12'. The same company that will be upgrading the SRB roadway has been selected to replace the pipe. Do not know the timeline to complete the work, likely the end of the year. This request for design funding was approved by the County.

#### Topic 2 Bridge to Bridge Path

Brooks to Marler bridge path has been stalled and started repeatedly. One of the issues is this is federal land where there had to be agreement between Eglin and other federal entities. About two months ago this was approved. Jason Autry requested \$3.73M for the construction of the path. It will be 12' wide and 4.7 miles long. It does have the support of Eglin Airbase. The total timeline of the construction is projected at 270 days with 60 additional days for planning: 330 total days.

#### Topic 3 Discussion with Mr. Autry from public works cable boxes and lane reduction

Old cable boxes that you see along SRB where there are many that are not maintained, rusted, and opened with wires exposed. This issue was brought forward to Brian Harrington by an OILA member. Brian had a discussion with Mr. Autry on this topic. Asked if these would be addressed as part of the SRB improvement plan? Mr. Autry explained that Century link has been unresponsive to fixing and there is a legal issue as they have ownership of that property. Brian asked if this will be part of the SRB planning? He mentioned that they are at the 60% phase of the SRB planning process. He then mentioned that the 2-road lane reduction is no longer a part of the plan, "it is off the table". The current plan is 3 lanes from Brooks bridge to El Matador with an east and west bound lane with one center turn lane. It will also include a 6' walking path. Brian asked when we'll know the official plan. Mr. Autry then offered to talk with the OILA membership to clarify the status of the SRB project.

Frank Adcock - provided comments about the necessity to ensure emergency services can provide necessary services and not be impacted by reducing from 4 to 3 lanes. In addition, with the added landscaping plans with Palm trees on both sides of the road will impact driver's ability to safely enter/exit SRB. The county also allowed a commercial business at the end of the Island that will also increase the volume of traffic utilizing SRB. Mr. Autry should have questions provided to him prior to the OILA membership meeting so he can completely address all membership concerns.

Brian Harrington opened discussion up to the membership on the venue & date for Mr. Autrey to speak to the membership. Frank Adcock offered to find out if there was room available at the El Matador. Brian Harrington stated he will contact Mr. Autrey's office and attempt to have him speak to the membership at the earliest availability and confirm the venue.
